 3. Experience in Special Education
 4. Experience in the development and implementation of behavioral plans.

1. When supervising a group of students, have the capacity to ensure the safety of, observe, supervise and assess all situations involving a student with behavior issues.
2. Have mobility, strength, and dexterity to be able to lift a student weighing up to 40 pounds and to retrieve a student who may run or has tantrums.
